General Price List

Prices are effective March 1, 2021 and are subject to change without notice.

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

PAYMENT POLICY

Payment is due at the time of the arrangement. We accept cash, personal checks, cashier's check, and all major credit cards. Credit card payments will incur a 3.5% convenience fee.

We also accept the proceeds of qualified insurance policies that are verified with the insurance company before acceptance and are determined assignable. Amounts beyond the amount assigned will be paid directly to the beneficiary.

PROFESSIONAL SERVICES

Basic Services of Funeral Director and Staff.....\$1295

This fee includes, but is not limited to, Staff to respond to initial call for service; arrangement conference with the family to discuss arrangements and to sign necessary forms and releases; arrangement of tributes; preparation and filing of necessary authorizations and permits; recording of Vital Statistics; preparation and placement of obituary; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, clergy and others as required. Also included in this fee are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, utility expenses, maintenance, taxes, inventory costs, record keeping, secretarial and administrative expenses.

The charge for our Basic Services fee will be added to the total cost of the arrangements you select. This fee is already included in our charges for direct cremation, immediate burial, and forwarding/receiving of remains.

PREPARATION OF THE DECEASED

Embalming.....\$695

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Use of staff for Memorial Service at your Church or other facility.....\$350

Our service includes setup of facilities for Memorial Service, coordination and setup of floral arrangements, supervision and attendance at service by licensed and/or certified staff, and supervision and attendance at committal or other disposition service.

Use of staff for Graveside Service.....\$350

Our service includes coordination and setup of floral arrangements, supervision and attendance at graveside service by licensed and/or certified staff, and necessary equipment.

Private viewing of unembalmed remains at our care center.....\$395

Additional charge of staff for Weekend service.....\$350

Additional charge of staff on Holidays.....\$500

Additional charge for Weekend or Holiday arrangement conference.....\$500

SPECIAL CHARGES

Forwarding Remains to another Funeral Home\$2195

This charge includes transfer of deceased to funeral home, basic services of Funeral Director and staff, embalming, and local transportation to airport. This charge does not include any other services, casket, air tray or airline fee.

Receiving Remains from another Funeral Home.....\$1595

This charge includes temporary shelter of remains, basic services of Funeral Director and staff, transportation of remains from Sacramento Airport and delivery to local cemetery or crematory. This charge does not include use of staff for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

Immediate Burial.....\$1595

This charge includes: Basic service of Funeral Director and staff, transfer of deceased into our care, arrangement conference with the family to discuss arrangements and to sign necessary forms, refrigeration, and transportation to local cemetery. Price does not include cemetery or government fees, the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

A. Immediate Burial with casket provided by purchaser.....\$1595
(All such containers must meet any cemetery and/or state requirement)

B. Immediate Burial with minimum casket selected from our Funeral Home.....\$2590

C. Immediate burial with casket selected from our Funeral Home.....\$1595
(In addition to the casket listed on the Casket Price List)

Direct Cremation.....\$1195

This charge includes: Basic services of the Funeral Director and staff, transfer of deceased into our care, refrigeration, transportation to crematory, necessary permits and authorizations and crematory fee, arrangement conference with the family to discuss arrangements and to sign necessary forms and releases. This charge does not include merchandise, the use of facilities and staff for any visitation, rites or ceremonies, public or private, prior to or after cremation, or sales tax or any other cash advance items.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of heavy fiberboard, heavy cardboard, or composition materials.
